COMMITTEE REPORTS:

<u>Finance</u>: Chris Churchwell presented the report. There are some issues regarding collection of tuition that are being addressed. Expenses are higher than anticipated due to the addition of employees to the healthcare plans (ACA mandates). The proposed 2016-2017 was provided for preliminary review. One item discussed was the increase in tuition/enrollment fees. Registration deadlines are being moved up one month, meaning registration fees increase after May 1. April 5 is the date for the Open House for Preschool/Pre-Kindergarten/Kindergarten; parents may register their children that day. Also the first payment to JACS as a beneficiary of an estate was received, and another disbursement will be received from this same estate soon.

<u>Development/Fundraising:</u> Kelly Kelso presented her report. The Annual Appeal is behind this year. Approximately \$6000 has been raised through the Phonathon. Multiple grant applications are still outstanding. The Auction has received \$12,000 in sponsorship so far and more sponsors are expected. Karen Lais has been hired as the Auction Chair and will receive a salary for this that will be determined.

OLD BUSINESS:

The preliminary 2016-2017 calendar was discussed. The NCEA will hold its convention in St. Louis in 2017, and a goal to have JACS well represented was discussed.
